# WEEE and RoHS Information

## **Disposal of Electrical and Electronic Equipment**

Under new government regulations issued in January 2007 we are all obliged and must play our part to ensure that the amount of waste of certain electrical and electronic equipment is reduced going forward. Furthermore when an item reaches it's End of Life and becomes waste we must work together to ensure that it is separated from household waste, collected separately and ultimately disposed of in an environmentally sound manner (recycled and recovered).

In essence some of the chemicals and metals in these electrical items can be harmful to the soil and human health when disposed of in landfill sites. In many cases the materials can be recovered and reused, saving natural resources and benefiting the environment. By adopting the new regulations and working together we can all reduce the amount of landfill, resulting contamination and unnecessary waste of reusable materials.

#### What products are covered by WEEE?

The WEEE regulations only applies to electrical or electronic items, simply, if the item is powered by, or operates by any form of electricity (ie, mains, batteries, solar power etc.) it is most likely to be included.

- IT and telecoms equipment (e.g. printers, calculators, phones, answer machines, barcode scanners etc)
- Office equipment (e.g. shredders, laminators, projectors, fan heaters, electronic scales, vacuum, air conditioner, electronic safes etc)
- Lighting equipment
- Electrical and electronic tools (e.g. drills, saws, angle grinders etc)
- Medical devices (e.g. defibrillators etc)
- Monitoring and control instruments (e.g. smoke detectors, electrical test meters, CCTV cameras etc)
- Other electrical or electronic devices (e.g. electronic door locks, torches, pressure washers, personal attack alarms etc) Any product bearing the "Wheelie bin symbol" is included in the WEEE regulations.

For your part as the consumer you are encouraged to examine your electrical waste before throwing it away and in particular look for the rating plate and if the following logo is present you must not throw it in your household waste.



Please take this waste to your nearest Designated Collection Facility (DCF) where special facilities exist for correct disposal.
